IN CONSIDERATION of Cullman County, allowing me to participate in the Smith Lake Park Fishing Tournament, hereinafter referred to as "Tournament", I, for myself, and on behalf of my spouse, children, parents, guardians, heirs, and next of kin, and any legal and personal representative, executors, administrators, successors, and assigns, do hereby agree to and make the following contractual representations pursuant to this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement, hereinafter referred to as "Agreement".

- 1. I hereby represent that (i) I am in good health and in proper physical condition to participate in the activities in which the Tournament provides; and (ii) I am not under the influence of alcohol or any illicit or prescription drugs which would in any way impair my ability to safely participate in Tournament; (iii) I have not been advised against activities by a health professional. I agree that it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate in activities.
- 2. I understand and acknowledge the physical and mental rigors associated with the activities in which the Tournament provides and realize that such activities are inherently dangerous and represent an extreme test of a person's physical and mental limits.
